

ABOUT THE ACETIE 2023 关于 2023 澳中博览会

The ACETIE was initiated by the Australia-China business community in 2018. It aims to promote bilateral economic and trade relations through the implementation of the Australia-China Free Trade Agreement and serve the interests of the business communities and the people of the two countries. With the support of the governments and the enthusiastic participation of the Australia-China business circles, the ACETIE has become the most influential business event between the two countries.

The previous ACETIE events were actively participated by hundreds of Australian and Chinese companies and organisations, invited government officials, business leaders and scholars to deliver important speeches, attracted tens of thousands of audiences and visitors, and reported by the major mainstream media in Australia and China.

The ACETIE annual event has been suspended during the Covid-19 pandemic. After the pandemic, the global economy is recovering and the Australia-China dialogue has resumed. Coupled with the long history and natural complementarity of Australia-China economic and trade relations, the Australia-China business community is full of confidence and hope, and the ACETIE 2023 will be held to promote such a good trend.

The ACETIE is supported by the Australian Trade and Investment Commission (Austrade), China Council for The Promotion of International Trade (CCPIT), the Victorian State Government, and City of Melbourne, partnered with the Australia China Business Council (ACBC) and China Chamber of Commerce in Australia (CCCA) Melbourne Branch. Founded in 1973, the ACBC has branches in all the major cities across the country and plays an influential role in the Australia-China economic and trade cooperation area as an advisor to the Australian Government. Founded in 2006, CCCA is a non-for-profit organization jointly formed by Chinese enterprises in Australia and has hundreds of members across the country.

The ACETIE organising committee is chaired by the Hon Andrew Robb AO, former Australian Minister for Trade and Investment. Mr Robb negotiated Free Trade Agreements with China, South Korea and Japan, as well as the 12 country Trans Pacific Partnership (TPP) free trade agreement and the Comprehensive Strategic Partnership with Sinapore.

澳中博览会获得澳大利亚联邦政府贸易委员会、中国贸易促进委员会、维多利亚州政府及墨尔本市政府的官方支持,并与澳大利亚中国工商业委员会 (ACBC) 和澳大利亚中国总商会 (CCCA) 墨尔本分会合作举办。ACBC 成立于 1973 年,分支遍布澳洲各大城市,作为澳大利亚政府的商业顾问之一,是澳中经贸合作领域中最权威的组织机构。CCCA 是中国驻澳大利亚的中资企业的联合组织,成立于 2006 年,各行业会员单位遍布全澳。

澳大利亚中国总商会墨尔本分会 China Chamber of Commerce in Australia Melbourne Branch

The Australia China Business Council (ACBC) is a membership-based, non-profit, non-governmental organisation comprised of a National Office, seven Branches, and more than 1500 representatives from over 900 Australian companies who do business with China.

Founded in Victoria in 1973, ACBC actively promotes two-way trade and investment, economic cooperation and understanding between the business communities of Australia and China.

ACBC plays an influential role as an advisor to the Australian Government on commercial relations with China. We are a strong supporter of the comprehensive China Australia Free Trade Agreement, designed to encourage the growth of business opportunities and more competitive bilateral trade between both nations.

With a National head office in Victoria plus Branch offices in each State and Territory, ACBC provides regular policy and business-focused activities for our members. We also run a comprehensive series of state and national events each year, which include forums, summits and roundtable presentations and a day of networking in Canberra with Australian Government Ministers and senior government officials.

The Australia China Business Council has close links with expatriate Australian groups in China, expatriate Chinese groups in Australia, as well as with officials and business forums in both countries. The ACBC actively participates in and leads trade missions to China with a specific focus on facilitating business-to-business dialog and achieving tangible outcomes.

澳大利亚中国工商业委员会(简称澳中商会)是一家非营利非政府,会员制机构。全国总会下设七个分会,900 多会员组织机构与中国有商务合作,会员代表超过 1500 名。

澳中商会于 1973 年在维多利亚州成立,多年来致力于促进双边贸易投资以及经济合作,推动中澳商界相互了解。

澳中商会作为澳洲政府与中国贸易关系方面的顾问发挥着举足轻重的作用。中澳自由贸易协定旨在扩大商业发展机会,促进两国间更具竞争力的双边贸易关系。澳中商会全力支持中澳自由贸易协定的全面推行。

澳中商会全国总会设在墨尔本,每一个州及领地都设有分会。澳中商定期为会员组织安排政策解读和商务交流的活动,还会每年举办一系列形式多样的全国性活动,包括论坛,高峰会议及圆桌研讨会,特别是一年一度的堪培拉社交日,届时澳洲政府各部部长及高级官员均会出席。

澳中商会与驻中国的澳洲商会,驻澳的中国商会及官员始终保持密切联系,并积极组织参与两国商业论坛。澳中商会活跃地加入或组织贸易代表团出访中国,加强两国商业对话,取得实质性成果。

China Chamber of Commerce in Australia (or CCCA for short) was founded in 2006 and is a non-profit national organisation jointly formed by trade associations representing Chinese investors across Australia. The CCCA has 34 directors in its management, with four branches and currently 328 members across New South Wales, Victoria, Western Australia and Queensland. Sydney branch has 147members, Perth branch has 56 members, Melbourne branch has 61 members and Brisbane branch has 64 members by the end of December 2017.

The business scope of the membership covers a wide range of industries including energy, mining, trade, finance, communication, transportation, real estate, manufacturing, tourism, agriculture and animal husbandry.

Recently, CCCA established five Committees, which are Legal and Compliance Committee, Aviation Committee, Resource and Energy Committee, Women Entrepreneur Committee and Foreign Relations Committee.

The Mission of the CCCA is to provide services to its members, protect their legal rights, promote the development of the bilateral China-Australia economic trade relationship, and enhance communication between companies in both countries. The organisation aims to serve as a bridge between Australia and China to facilitate the business development of its members in the two countries.

The China Chamber of Commerce in Australia (CCCA) Melbourne branch is the peak body representing Chinese companies in Victoria and Tasmania. The chamber members from a range of sectors including energy, resources, finance, telecommunications, real estate, agriculture and manufacturing. CCCA Melbourne's mandates are to serve its members, protect their legitimate rights and interests, encourage better business cooperation between different companies and promote better business and economic relations between China and Australia.

澳大利亚中国总商会是中国驻澳大利亚的中资企业的联合组织,为非营利性的社团,成立于2006年。截止2017年12月,共有328家会员单位,分布在新南威尔士州、维多利亚州、西澳大利亚州和昆士兰州。

总部设在悉尼,并分到在悉尼、墨尔本、珀斯和布里斯斯建有四个分会。其中,悉尼分会共147家会员单位、墨尔本分会共61家会公单位、珀斯分会共56家会员单位、布里斯班分会目前共64家会员单位。会员业务涉及能源、矿产、贸易、金融、通信、运输、房地产、制造、旅游农牧业等多个领域。总商会目前有34名理事,其中设会1位会长和4位副会长,各分会会长由总商会会长或副合长兼任。目前总商会成立了5个委员会,分别是法律与合规委员会、航空业委员会。

总商会的宗旨是为会员服务,维护会员的合法权益,促进中澳经济贸易关系的发展和企业间的交流,为会员在澳大利亚和中国的业务发展发挥桥梁和纽带作用。

澳大利亚中国商会(CCCA)墨尔本分会是代表中国企业在维多利亚州和塔斯马尼亚州的最高机构,成员来自能源、资源、金融、电信、房地产、农业和制造业等一系列行业。墨尔本商会的宗旨是为会员服务,维护会员的合法权益,鼓励不同公司之间更好的商业合作,促进中澳两国更好的商业和经济关系。
